ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, JPA OBO Associação Franciscana de Ensino Senhor Bom Jesus - DSA 2 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

Withdrawing your consent
